AFFIDAVIT OF CORRECTION

BE IT KNOWN, that on this 7th day of August, 1991, before me, the undersigned Notary Public in and for the parish and state aforesaid, and in the presence of the undersigned competent witnesses, personally came and appeared:

RALPH E. HOOD, a resident of the lawful age of the Parish of East Baton Rouge, State of Louisiana;

(hereinafter referred to as "Apparer") who declared that on August 28, 1990, by act passed before Apparer, a Notary Public in and for the Parish of East Baton Rouge, State of Louisiana, Village Properties, A Joint Venture, and The Lake at White Oak Homeowners Association, Inc., executed an act entitled "Declaration of Covenants and Restrictions for the Lake at White Oak, Sixth Filing, Part I" which act was recorded as Original 665, Bundle 10172, official records of the Clerk and Recorder for East Baton Rouge Parish, Louisiana ("the restrictions"), affecting those lots in The Lake at White Oak, Sixth Filing, Part I, containing Lots Number 401 through 428, inclusive, as shown on a map entitled "Final Plat of The Lake at White Oak, Sixth Filing, Part I," prepared by Evans-Graves Engineers, Inc., dated August 15, 1990, recorded as Original 357, Bundle 10171, official records of the Clerk and Recorder for East Baton Rouge Parish, Louisiana ("the map").


Although the map clearly shows that the lots in The Lake at White Oak, Sixth Filing, Part I, are numbered Lots 401 through 429, inclusive, a typographical error was made on the restrictions in that the lots declared to be affected by the restrictions were Lots Number 401 through 428, inclusive.

Apparer therefore makes this act to reform and correct the restrictions so as to have the lots affected by the restrictions to read "Lots Number 401 through 429 inclusive."

AND, I, NOTARY, do authorize and request the Clerk and Recorder of Conveyances and Mortgages for the Parish of East Baton Rouge, State of Louisiana, to record and index this Affidavit of Correction pursuant to the provisions of Louisiana Civil Code Article 3385.1.
